

SCOPE OF WORK FOR GAS TURBINE INTAKE AIR FILTER DUCT MINOR REPAIR WORK AND FILTER ELEMENT REPLACEMENT WORK

- 1. Provide Scaffoldings on both deck of Gas Turbine air filtration system. (Approx area 550 square feet x 2 decks at 4 meter and 6 meter level)
- 2. Remove the old filters element- 360 numbers from the duct system.
- 3. Clean out side & inside of the ducts.
- 4. Inspect filter clamp bracket, clamp bar, formed channel, handles and the filter fixing seat portion for any corrosion/damage.
